AGUA HEDIONDA LAGOON AGREEMENT

In consideration of the issuance of a permit to use Agua Hedionda Lagoon, I/we agree to indemnify and save harmless the City of Carlsbad, and its officers and employees, from and against any and all claims, demands, liabilities, or losses of any kind or nature which the City, its officers, or employees may sustain or incur or which may be imposed upon them for injury to or death of persons or damage to property as a result of or arising out of my/our use of Agua Hedionda Lagoon including any injury or death to me/us or my/our family, or damage to my/our property. I/We further agree to pay any and all costs and reasonable attorneys' fees incurred by the City on account of any such claims, demands, liabilities, or losses. This agreement shall not apply to claims, demands, liabilities or losses proved to have been caused solely by the active negligence or intentional misconduct of the city or its officers or employees. In executing this agreement, I/we accept all risks present in using the Lagoon including but not limited to risks created by the use of the Lagoon by others, or from the condition of the Lagoon surface, bottom or shoreline, except to the extent that those risks are created by active negligence of the City or its officers or employees.

**2024 REQUIREMENTS FOR
AGUA HEDIONDA LAGOON USE PERMIT**

- The registered owner listed on DMV Registration **MUST** be present at the time of purchase.
- Any powerboat 20’6” and over must first be inspected and approved.
- **Municipal Code 11.24.080 Maximum vessel length.**
The maximum vessel length allowed in the inner lagoon, excluding rescue, research, and maintenance vessels, shall be 21 feet or less for powerboats, 18 feet or less for passive vessels and 12 feet or less for personal watercraft. Notwithstanding the foregoing, powerboats used for skiing may be 23 feet if the manufacturer’s certified slalom wake rise rating is less than nine inches. (Ord. NS-509 § 13, 1999; Ord. NS-292 § 1, 1994)
- Permits are **NOT refundable or transferable.**
- **Provide a copy of the current year’s registration/DMV Certificate of Number,** which is required for all watercraft **except** passive vessels and sailboats under 8 feet.
- All power vessels require a launch permit.
- Please obtain your launch permit **PRIOR** to applying for your City permit.

PERMIT FEES:

- Annual permits are valid Jan. 1st through Dec. 31st (and are prorated on September 1).
- Fees are based on residency and are non-refundable and non-transferable.
- Proof of residency required for discounted rate.
- Checks should be made payable to the City of Carlsbad.
- All major credit cards are accepted.
- If a Permit Sticker is lost a Replacement Decal Sticker is \$8
