NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN to you, because your interest may be affected, that the City Council of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5 p.m. on Tuesday, Nov. 19, 2024, to consider a series of amendments to the city's General Plan, Zoning Ordinance, and Local Coastal Program to specify and clarify code amendments and permit review procedures for new or expanded airport land uses.

The proposed amendments to the General Plan (Land Use and Community Design Element) and Zoning Ordinance (portion of the General Plan and to Zoning Ordinance (Title 21 of the Carlsbad Municipal Code) incorporate state law definitions for "airport" and "airport expansion," require new or expanded "airport" land uses to obtain a new or amended Conditional Use Permit, and permit "airport" development only within the current boundary of Palomar Airport, etc. The proposed code amendments include amendments to the city's Local Coastal Program for those areas within or impacting Coastal Zone areas. The project also includes new procedures concerning the city's role, review, and approval of an airport expansion or enlargement plan, or where there is an acquisition of property beyond the current boundaries of Palomar Airport. No construction or development is proposed in connection with the requested code amendments and procedures.

The code amendments have been reviewed in accordance with the California Environmental Quality Act (CEQA) and the requirements of the city. In accordance with CEQA, the project is within the scope of the Supplemental Environmental Impact Report (SEIR) approved earlier; and the certified SEIR adequately describes the proposed project for the purposes of CEQA. The City Council will be asked to adopt Addendum No. 2 to the Housing Element Implementation and Public Safety Element Update SEIR.

On October 16, 2024, the City of Carlsbad Planning Commission voted 6/1 (Merz – No) to recommend approval of the addendum and code amendments and procedures.

Those persons wishing to speak on this item are cordially invited to attend the public hearing. Copies of the staff report will be available on and after Friday, Nov. 15, 2024.
