However, our \$514,477 per year compensated City Manager does NOT represent Carlsbad well and has squandered millions in homeless grants to INCREASE Carlsbad homeless 87% this year. Instead, this guy imports homeless from where he lives in San Diego and puts them in District 1's Windsor Pointe, which was supposed to help Carlsbad's homeless. However (as you know), this crime-ridden dumpster fire houses only 5 tenants with any Carlsbad affiliation out of 50 apartments and the same homeless sleeping in the streets of the Village and in cars on Palm Avenue are still there. And he refuses to remedy this.
