About the commission

The Community-Police Engagement Commission shall consist of five members to be appointed pursuant to Section 2.15.050(A) with staggered terms as provided in Section 2.15.060.

The purpose of the commission is to provide a cooperative and collaborative forum for the community and police leadership to learn and discuss the challenges of modern-day policing and provide a community perspective about public safety challenges. The commission will work collaboratively with the Police Chief to provide advice, support, and recommendations relating to current or newly considered policies and programs with an overarching goal of building trust and fostering strong police-community relations.

Persons with ongoing litigation against the city related to police matters shall be ineligible to serve on the commission. In addition, current Carlsbad Police Department employees and their parents or children are ineligible to serve on the commission.

The purpose of the commission is to provide a cooperative and collaborative forum for the community and police leadership to learn and discuss the challenges of modern-day policing and provide a community perspective about public safety challenges. Eligibility

Members must be residents of Carlsbad and registered voters.

Meeting dates/times

Regular meetings are held in the City Council Chamber in January, April, July, and October on the last Monday of the month at 5 p.m.

Commissioner requirements/duties

Attend monthly commission meetings.
File an annual "Statement of Economic Interests" form.
Complete ethics training and sexual harassment prevention training every two years.

Appointment process

Applications are available on the city's website at carlsbadca.gov and in the City Clerk's Office, City Hall at 1200 Carlsbad Village Drive, Carlsbad.

The representatives from District 2 and District 4 will nominate an applicant at a City Council meeting. Approval from a majority of the City Council is required to confirm the appointment.
